Based on the 2017 Financial Performance of ThaiBev Group, on 27 Feb 2018, I was awarded a new contingent award of 76,000 shares ("2017/2018 Initial Award") under LTIP, where the actual final number of shares ("2017/2018 Final Award") that will be issued to me shall be subject to achievement of certain pre-determined performance targets, other terms and conditions and rules of LTIP, and will range from 0% to 120% of the 2017/2018 Initial Award. On 14 Jan 19, I received a letter dated 2 Jan 2019 informing me that my 2017/2018 Final Award was decreased to 51,300 shares in total, of which 17,100 shares were issued to me on 1 Feb 2019, 17,100 shares were issued to me on 3 Feb 2020, and the remainder shall only be issued to me in future in accordance with the vesting schedule and subject to terms and conditions and rules of LTIP.

Based on the 2019 Financial Performance of ThaiBev Group, on 31 January 2020, I was awarded a new contingent award of 112,000 shares ("2019/2020 Initial Award") under the LTIP, where the actual number of shares ("2019/2020 Final Award") that will be issued to me shall be subject to achievement of certain pre-determined performance targets, other terms and conditions and the rules of the LTIP, and will range from 0% to 120% of the 2019/2020 Initial Award.
