("Risen Mark") has an interest in 833,335,000 THBEV Shares.

Charoen Sirivadhanabhakdi and his spouse, Khunying Wanna Sirivadhanabhakdi, jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in each of Maxtop, Golden Capital and Risen Mark.

Each of Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Golden Capital, Maxtop and Risen Mark have an interest.
