There will be no change in the aggregate interests held by the ultimate majority shareholders of the Company, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi in the Company arising from the completion of the transaction. Completion of the transaction under the SPA has not taken place and is subject to the satisfaction of certain conditions as specified under the SPA. Siriwanan therefore has a deemed interest in the Sale Shares.

As Siriwanan is a wholly-owned subsidiary of Siriwana Co., Ltd., Siriwana Co., Ltd. has a deemed interest in the Shares in which Siriwanan has an interest.
