On 13 December 2021, Siritawan Co., Ltd ("Siritawan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 1,470,000,000 THBEV Shares ("Sale Shares") from Golden Capital upon completion of the transaction. There will be no change in the aggregate interests held by the ultimate majority shareholders of the Company, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi in the Company arising from the completion of the transaction. Completion of the transaction under the SPA has not taken place and is subject to the satisfaction of certain conditions as specified under the SPA. Siritawan therefore has a deemed interest in the Sale Shares.

As Siritawan is a wholly-owned subsidiary of Siritawana Co., Ltd., Siritawana Co., Ltd. has a deemed interest in the Shares in which Siritawan has an interest. Siritawana also has a direct interest in 11,368,060,000 THBEV Shares. Shiny Treasure Holdings Limited holds a 49% direct interest in Siritawana and is therefore deemed to be interested in all of the THBEV Shares in which Siritawana has an interest.
