On 13 December 2021, Siriwanan Co., Ltd ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 1,470,000,000 THBEV Shares from Golden Capital upon completion of the transaction. Completion of the transaction took place on 17 February 2022. There will be no change in the aggregate interests of the ultimate majority shareholders of the Company, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi, in THBEV arising from the completion of the transaction.

Maxtop Management Corp ("Maxtop") has an interest in an aggregate of 3,706,627,762 THBEV Shares. Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in Golden Capital and Maxtop.

Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi also jointly hold a 51% direct interest in Siriwana Co., Ltd. ("Siriwana"). Siriwana holds a direct interest in 11,368,060,000 THBEV Shares. Siriwanan is a wholly-owned subsidiary of Siriwana.

Each of Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Siriwana and Siriwanan have an interest.
