

On 13 December 2021, Siriwanan Co., Ltd ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 1,470,000,000 THBEV Shares ("Sale Shares") from Golden Capital upon completion of the transaction. There will be no change in the aggregate interests of the ultimate majority shareholders of the Company, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi, in the Company arising from the completion of the transaction. Completion of the transaction took place on 17 February 2022.

Maxtop Management Corp ("Maxtop") has an interest in an aggregate of 3,706,627,762 THBEV Shares.

MM Group Limited ("MM Group") holds a 100% direct interest in Golden Capital and Maxtop. MM Group is therefore deemed to be interested in all of the THBEV Shares in which Golden Capital and Maxtop have an interest.
