There will be no change in the aggregate interests of the ultimate majority shareholders of the Company, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi, in the Company arising from the completion of the transaction. Completion of the transaction took place on 17 February 2022. Siriwanan therefore has a direct interest in the Sale Shares.
