Invitation to 2022 Virtual Annual Information Meeting for Shareholders in Singapore

Thai Beverage Public Company Limited (“**ThaiBev**”) cordially invites its shareholders to attend the 2022 Virtual Annual Information Meeting for Shareholders in Singapore (“**Information Meeting**”). This Information Meeting is an annual event organized by ThaiBev to provide an opportunity for its shareholders in Singapore to hear from the key directors and management.

This year, for the safety of attendees, ThaiBev has decided to hold the Information Meeting by electronic means via a live webcast (comprising both video (audio-visual) and audio-only feeds). Shareholders will not be able to attend the Information Meeting in person as there will be no physical meeting venue in Singapore.

- Via : live webcast/audio for the shareholders whose status have been registered and verified
- Time : 11:00 hrs. – 12:00 hrs. (Singapore time)

During the Information Meeting, a presentation will be delivered to provide shareholders with more insights into and updates on ThaiBev’s business. The presentation slides used during the Information Meeting will also be made available to all shareholders through SGXNET and ThaiBev’s website after the Information Meeting. As this is an informal meeting, please note that no resolutions will be considered. Shareholders should also note that the recording of the live webcast in any form is also strictly prohibited.

HOW TO REGISTER

Shareholders who wish to attend the Information Meeting via electronic means should note the following:

- (a) **PRE-REGISTRATION:** Shareholders who wish to attend the Information Meeting **must pre-register pursuant to the methods prescribed in the item (i), (ii) or (iii) below by 11:00 hrs (Singapore time) on Thursday, 15 September 2022** for verification purposes. Following successful verification, details on how to join the Information Meeting will be sent to you by **Monday, 19 September 2022** at the email you have specified in your pre-registration details.

Please note that only depositors whose securities accounts with Thailand Securities Depository Co., Ltd. and The Central Depository (Pte) Limited are credited with ThaiBev shares **as at 17:00 hrs (Singapore time) on Thursday, 15 September 2022** are eligible to attend the Information Meeting. Shareholders who hold ThaiBev shares through a nominee, brokerage firm, bank, broker-dealer or other similar service provider **as at 17:00 hrs (Singapore time) on Thursday, 15 September 2022** may attend the Information Meeting if they provide a confirmation letter from the agent that the agent is providing such services to the person, and that the person holds ThaiBev shares through the agent. Such letter must be received by us by **11:00 hrs (Singapore time) on Thursday, 15 September 2022** via any of the following methods:

- (i) via the pre-registration website at www.aim.thaibev.com; or
