On 28 September 2022, Siriwanan Co., Ltd ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 730,000,000 THBEV Shares ("Sale Shares") from Golden Capital upon completion of the transaction. Completion of the transaction has not yet taken place. There will be no change in the aggregate interests of the ultimate majority shareholders of THBEV, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi, in THBEV arising from the completion of the transaction. Completion of the transaction under the SPA has not taken place and is subject to the satisfaction of certain conditions as specified under the SPA. Siriwanan therefore has a deemed interest in the Sale Shares.

As Siriwanan is a wholly-owned subsidiary of Siriwana Co., Ltd, Siriwana Co., Ltd has a deemed interest in the THBEV Shares in which Siriwanan has an interest.
