On 28 September 2022, Siriwanan Co., Ltd ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 730,000,000 ordinary shares of THBEV ("Sale Shares") from Golden Capital upon completion of the transaction. Completion of the transaction under the SPA took place on 30 November 2022. There will be no change in the aggregate interests of the ultimate majority shareholders of THBEV, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi, in THBEV arising from the completion of the transaction.

Maxtop Management Corp has an interest in an aggregate of 2,976,627,762 ordinary shares of THBEV. Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in Golden Capital and Maxtop.

Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi also jointly hold a 51% direct interest in Siriwana Co., Ltd ("Siriwana"). Siriwana holds a direct interest in 11,368,060,000 ordinary shares of THBEV. Siriwanan holds a direct interest in 2,200,000,000 ordinary shares of THBEV. Siriwanan is a wholly-owned subsidiary of Siriwana.

Each of Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Maxtop Management Corp, Siriwana and Siriwanan have an interest.
