On 28 September 2022, Siriwanan Co., Ltd ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 730,000,000 THBEV Shares ("Sale Shares") from Golden Capital upon completion of the transaction. There will be no change in the aggregate interests of the ultimate majority shareholders of THBEV, Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi, in THBEV arising from the completion of the transaction. Completion of the transaction took place on 30 November 2022. Siriwanan therefore has a direct interest in the Sale Shares.
