On 12 October 2023, Maxtop Management Corp ("Maxtop") entered into a sale and purchase agreement with Golden Capital (Singapore) Limited ("Golden Capital"), pursuant to an internal restructuring which Maxtop disposed of 700,000,000 THBEV Shares to Golden Capital. Following this, Golden Capital had an interest in an aggregate of 700,000,000 THBEV Shares, and Maxtop had an interest in an aggregate of 2,276,627,762 THBEV Shares.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in each of Maxtop and Golden Capital. Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Golden Capital and Maxtop have an interest.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi also jointly hold a 51% direct interest in Siriwana Co., Ltd ("Siriwana"). Siriwana holds a direct interest in 11,368,060,000 THBEV Shares. Siriwanan Co., Ltd. ("Siriwanan") holds a direct interest in 2,200,000,000 THBEV Shares. Siriwanan is a wholly-owned subsidiary of Siriwana.

Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Siriwana and Siriwanan have an interest.
