On 18 October 2023, Siriwanan Co., Ltd. entered into a sale and purchase agreement with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 700,000,000 THBEV Shares from Golden Capital upon completion of the transaction. There will be no change in the aggregate interests of the ultimate majority shareholders of the Company, Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi, in the Company arising from the completion of the transaction. Completion of the transaction took place on 23 November 2023.

Maxtop Management Corp ("Maxtop") has an interest in an aggregate of 2,276,627,762 THBEV Shares.

MM Group Limited ("MM Group") holds a 100% direct interest in Maxtop. MM Group is therefore deemed to be interested in all of the THBEV Shares in which Golden Capital and Maxtop have an interest.
