On 18 October 2023, Siriwanan Co., Ltd. ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 700,000,000 ordinary shares of THBEV ("Sale Shares") from Golden Capital upon completion of the transaction. Completion of the transaction under the SPA took place on 23 November 2023. There will be no change in the aggregate interests of the ultimate majority shareholders of THBEV, Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi, in THBEV arising from the completion of the transaction.

Maxtop Management Corp ("Maxtop") has an interest in an aggregate of 2,276,627,762 THBEV shares. Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in Golden Capital and Maxtop.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi also jointly hold a 51% direct interest in Siriwana Co., Ltd. ("Siriwana"). Siriwana holds a direct interest in 11,368,060,000 ordinary shares of THBEV. Siriwanan holds a direct interest in 2,900,000,000 ordinary shares of THBEV. Siriwanan is a wholly-owned subsidiary of Siriwana.

Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Maxtop, Siriwana and Siriwanan have an interest.
