On 18 March 2024, Siriwanan Co., Ltd. ("Siriwanan") entered into a sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") pursuant to an internal restructuring to acquire 1,776,627,762 THBEV Shares ("Sale Shares") from Golden Capital upon completion of the transaction. There will be no change in the aggregate interests of the ultimate majority shareholders of THBEV, Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi, in THBEV arising from the completion of the transaction. Completion of the transaction under the SPA has not taken place and is subject to the satisfaction of certain conditions as specified under the SPA. Siriwanan therefore has a deemed interest in the Sale Shares.

As Siriwanan is a wholly-owned subsidiary of Siriwana Co., Ltd. ("Siriwana"), Siriwana has a deemed interest in the THBEV Shares in which Siriwanan has an interest. Siriwana also has a direct interest in 11,368,060,000 THBEV Shares. Shiny Treasure Holdings Limited holds a 49% direct interest in Siriwana and is therefore deemed to be interested in all of the THBEV Shares in which Siriwana has an interest.
